### Federal city lodging and meals & incidental expenses (M&IE) rates

### Pre-boarding Allowance for Airport Check-In

- Intra-State – Not to exceed 90 minutes prior to flight departure time
- Out-of-State – Not to exceed 3 hours prior to flight departure time

### Reduction of M&IE Allowance

If reduction of meals is required, use the following table to reduce the M&IE allowance accordingly.

MEAL	PERCENTAGE OF M&IE
Breakfast	20 percent
Lunch	30 percent
Dinner	50 percent

### Backcountry Travel Meal Allowance

Use the following table, to determine meal eligibility for fractional days, when providing a meal allowance for backcountry travel where commercial food establishments are unavailable.

QTR	TIME OF DEPARTURE/RETURN	ELIGIBLE MEAL
1	12:01 AM - 6:00 AM	N/A
2	6:01 AM - NOON	Breakfast
3	12:01 PM - 6:00 PM	Lunch
4	6:01 PM - MIDNIGHT	Dinner

\$20.00 per day (Breakfast -- \$6.66; Lunch -- \$6.67; Dinner -- \$6.67)
